Pat Claire opened the meeting up for public comment for the 2023 budget at 6:10 pm. No comment was made. Mike Sanders motioned to close the public comment. Jason Fisher seconds. All in favor. Motion carried. Closed at 6:15 pm.

# Disconnect Hearing

Jason Overman was present to discuss his water bill with the Council. Due to an accident and a water leak, he has had some issues with his bill. Sara Finley told the Council that she had called the business that helped with his leak and they were suppose to call her back with more information. Once we get more information, we can decide what needs to be done.

Mike Sanders motioned to proceed with disconnects. Pat Claire seconds the motion. All in favor, motion carried.

# **Approval of Prior Minutes**

# **Department Heads**

John Budreau stated Ken Smith will be in touch with him on repaving the three blocks downtown with possibly releveling the sidewalks that need repaired for next year.

Nate Besse asked the Council if Clayton could attend the Alliance fall conference. All is paid for except the hotel. Cost would be around \$280. Mike Sanders motions to accept Clayton's Conference.

Jason Fisher seconds. All in favor. Motion carried.

Nate mentioned that IDEM would be coming Friday for training at the wastewater plant.

Nate also mentioned that the truck the Council has approved is not available. Possibly would need to go with a 2023. He is now looking at quotes for a Generator at the East Lift Station and Lingle Lift Station instead.

Sean Heim was presented and stated to the Council that he sent out around 28 Ordinance Violations letters recently.

John Budreau mentioned he had contacted NIPSCO regarding standing water on the project that had just done on St. Rd. 55 and Maple. NIPSCO is suppose to be fixing the issue.
